Public Health Forum Brings Together Public Health and Planners to Build Ideas for Healthier Communities in Ontario

Toronto, Ont. – On the evening of September 28th over 250 public health and planning professionals will convene at the Courtyard by Marriott Downtown Toronto to kick off the OPHA Fall Forum, Taking Action on the Built Environment: Building Healthy Public Policy. The event begins at 7:00 p.m. with a welcome from Minister Margarett Best from the Ministry of Health Promotion and Sport. This will be followed by a keynote speech by Dr. David Mowat, who will then moderate a panel discussion. Panelists include the newly appointed Minister of Research and Innovation, Minister Glen Murray; Dr Bob Nosal, Commissioner and Medical Officer of Health, Halton Region Health Department; and David Oikawa, Manager of Community Planning, City of Toronto.

On the morning on September 29th, delegates will convene again at 8:30 a.m. for a welcome by Dr. Vivek Goel, President and CEO of the Ontario Agency for Health Protection and Promotion. This will be followed by a Keynote Address from Dan Leeming, Founding Partner of the Planning Partnership. Forum participants will then attend one of five facilitated sessions around the following themes: access to recreation, healthy and sustainable transportation, access to healthy foods, prevention of injury/violence, and healthy housing environments. Many of the sessions feature short presentations from organizations including Evergreen, Parks and Recreation Ontario, Share the Road Cycling Coalition, the Ontario Professional Planners Association, and the Canadian Environmental Law Association.

The OPHA Fall Forum will provide an opportunity for public health professionals and other professionals working on the built environment to shape and advance policies in order to create healthier, more equitable, and more sustainable communities. The link between the built environment and health has already been well established in the field of public health. The unique and innovative design of this Forum will create an interactive, think tank environment that will foster the development of policy solutions to built environment issues across Ontario.
