## **Ontario Budget Pleases and Disappoints Public Health**

Toronto, March 23, 2007 - The Ontario Public Health Association (OPHA) congratulates the McGuinty government on many of the initiatives announced in yesterday's provincial budget, including those aimed at helping low-income children and families. At the same time, the Association, which provides leadership on issues affecting the public's health and strengthens the impact of people who are active in public and community health throughout Ontario, is disappointed that a number of key areas of public health have been overlooked. These include increased funding for Public Health units, injury prevention initiatives and the Ministry of Health Promotion's Healthy Eating and Active Living (HEAL) strategy.

"Certainly there are some positive announcements in this budget," said Dr Garry Aslanyan, OPHA President, "The increase in minimum wage and the end of the clawback of the National Child Benefit Supplement are important steps toward alleviating poverty in Ontario."

OPHA is also pleased with increased funding to the Communities in Action Fund. "Much of our work, and indeed much of the work going on today in public health and health promotion, is about preventing chronic disease," said OPHA Executive Director Connie Uetrecht. "As we know, healthy eating and active living is an integral element of that challenge, and we would have been even more pleased with this budget if the government's own HEAL program's resources had been expanded to help carry out their essential work."

The government's announced plan to implement all 121 recommendations of the Walkerton inquiry and to increase funding for several safe water initiatives is also welcome news to OPHA, whose many members have actively sought changes that would ensure that all Ontarians have access to safe drinking water.

OPHA looks forward to continuing and expanding its work with the government on many initiatives and programs that promote and protect the health of the residents of this province.
