

RESOLUTIONS #2 to #6

RESOLUTION #2 RE: CHANGE IN OPHA MEMBERSHIP FEES

WHEREAS the annual fees for individuals shall be set by the Board of Directors and approved by the members at a meeting of the Association,

WHEREAS the membership fees for individuals have not been raised in over five years,

WHEREAS the OPHA Board of Directors agreed to propose on August 16, 2011 to increase the membership fees in order to support the need for financial sustainability,

THEREFORE BE IT RESOLVED THAT the Ontario Public Health Association increase the Individual Membership fee category as follows:

- \$135 for the period of April 1, 2012 to March 31, 2013,
- \$150 for the period of April 1, 2013 to March 31, 2014, and
- \$155 for the period of April 1, 2014 to March 31, 2015,

AND FURTHER BE IT RESOLVED THAT the Board of Directors be directed to review the fees prior to the 2014 Annual General Meeting.

All fees are to become payable on the first day of the membership time period described.

RESOLUTION #3 RE: CHANGE IN OPHA MEMBERSHIP FEES

WHEREAS the annual fees for all other individual class memberships not mentioned referenced in Resolutoin #1 shall be set by the Board of Directors and approved by the members at a meeting of the Association,

WHEREAS the membership fees for these individuals have not been raised in over five years,

WHEREAS the OPHA Board of Directors agreed to propose on August 16, 2011 to increase the membership fees in order to support the need for financial sustainability,

THEREFORE BE IT RESOLVED THAT the Ontario Public Health Association increase the Constituent Society Individual Membership Fee as follows:

- \$90 for the period of April 1, 2012 to March 31, 2013,
- \$100 for the period of April 1, 2013 to March 31, 2014, and
- \$115 for the period of April 1, 2014 to March 31, 2015,

AND FURTHER BE IT RESOLVED THAT the Board of Directors be directed to review the fees prior to the 2014 Annual General Meeting.

All fees are to become payable on the first day of the membership time period described.

RESOLUTION #4 RE: CHANGE IN OPHA MEMBERSHIP FEES

WHEREAS the annual fees for individuals shall be set by the Board of Directors and approved by the members at a meeting of the Association,

WHEREAS the membership fees for individuals have not been raised in over five years,

THEREFORE BE IT RESOLVED THAT the Ontario Public Health Association increase the fees for all other categories not described in Resolution #1 and #2 as follows:

- \$75 for the period of April 1, 2012 to March 31, 2013,
- \$85 for the period of April 1, 2013 to March 31, 2014, and
- \$95 for the period of April 1, 2014 to March 31, 2015,

AND FURTHER BE IT RESOLVED THAT the Board of Directors be directed to review the fees prior to the 2014 Annual General Meeting.

All fees are to become payable on the first day of the membership time period described.

RESOLUTION #5 RE: CHANGE IN OPHA CONSTITUENT SOCIETY MEMBERSHIP FEES

WHEREAS the annual fees for Constituent Societies shall be set by the Board of Directors and approved by the members at a meeting of the Association for 2011-12,

WHEREAS OPHA policies for 1990 stated that the fees for Constituent Societies be set at \$750 annually for a three-year period

WHEREAS these fees were increased to \$1000 on January 1, 2005,

WHEREAS the fees for Constituent Societies include two Individual Memberships in OPHA and benefits of membership such as collective advocacy and providing leadership on issues which affect the public's health,

WHEREAS the OPHA Board of Directors agreed to propose on August 16, 2011 to increase the membership fees in order support the need for financial sustainability,

THEREFORE BE IT RESOLVED THAT the Ontario Public Health Association increase the Constituent Society fees as follows:

- \$2000 for the period of April 1, 2012 to March 31, 2013,
- \$4000 for the period of April 1, 2013 to March 31, 2014, and
- \$4400 for the period of April 1, 2014 to March 31, 2015,

AND FURTHER BE IT RESOLVED THAT the Board of Directors be directed to review the fees prior to the 2014 Annual General Meeting.

All fees are to become payable on the first day of the membership time period described.

RESOLUTION #6 RE: PROPOSED FEES FOR NEW MEMBERSHIP CLASS, ORGANIZATIONAL MEMBERSHIP

WHEREAS the class of Organizational Membership was approved at the October 5, 2011 Annual General Meeting,

WHEREAS the annual fees for Organizational Membership shall be set by the Board of Directors and approved by the members at a meeting of the Association for 2011-12,

WHEREAS the fees for Organizational Membership includes benefits of membership such as collective advocacy and providing leadership on issues which affect the public's health, access to work groups, one vote privilege,

WHEREAS the OPHA Board of Directors agreed to propose on August 16, 2011 to establish a new membership class and introduce fees for this class in order to support the need for financial sustainability and enhanced inclusiveness,

THEREFORE BE IT RESOLVED THAT the Ontario Public Health Association increase the Organizational Membership fees as follows:

- \$1500 for the period of April 1, 2012 to March 31, 2013,
- \$1750 for the period of April 1, 2013 to March 31, 2014, and
- \$2000 for the period of April 1, 2014 to March 31, 2015,

A AND FURTHER BE IT RESOLVED THAT the Board of Directors be directed to review the fees prior to the 2014 Annual General Meeting.

All fees are to become payable on the first day of the membership time period described.
