Re: Government of Ontario's 'Investing in a Stronger Public Health Sector' Announcement

On behalf of the leaders and members of the Ontario Public Health Association (OPHA), we are writing to you to express our support and gratitude regarding the government's announcement outlining funding increases for the public health sector. We are pleased to see a return to the previous 75 percent provincial / 25 percent municipal cost-sharing ratio, as well as a one percent increase in funding in each of the next three years.

As we shared in our 2023 budget submission, OPHA believes that increased sustainable funding for a robust and locally driven public health system will help to ensure the implementation of essential health promotion and protection activities including population health assessment, health equity, emergency management, chronic disease prevention, food safety, healthy environments, healthy growth and development, immunization, infectious communicable diseases prevention and control, oral health, safe water, school health, and substance misuse prevention. The government's funding announcement is a positive move in the right direction and OPHA looks forward to discussing future investments in public health to ensure that the sector can meet its ongoing mandate, as well as respond to urgent issues including pandemics, the opioid crisis, housing and homelessness, and the impacts of climate change among others.

OPHA is also very pleased to see the government's announcement acknowledge that the impact of the pandemic has demonstrated the importance of a resilient public health system. During the pandemic, public health staff and management have been at the forefront of the response. They displayed agility to meet changing directives, worked tirelessly over long hours to meet growing demands, and faced unpredictable situations as well as risks of infection for themselves and their loved ones. OPHA would welcome the opportunity to discuss how we can restore and strengthen the public health workforce as the backbone of the system.

Again, on behalf of our 500 members and our constituent societies, OPHA is grateful for your announcement and recognition of the public health system and its role in ensuring healthy communities for all Ontarians.
